A RESOLUTION OF THE CALAVERAS CONSOLIDATED FIRE PROTECTION DISTRICT ALLOWING THE FIRE CHIEF TO SIGN THE MONTHLY REGULAR AND CALCARD TRANSMITTALS ONLY WHEN THERE IS A LACK OF A QUORUM

WHEREAS the Calaveras Consolidated Fire Protection District, Board of Directors regular schedules meetings on the fourth (4th) Monday of the month; and

WHEREAS the district is faced with a lack of a quorum due to board members being out on Strike Teams within their regular full time employment; and

WHEREAS the Board of Directors understands that this could create late fees with vendors, and
